

# Nominations for Election to the Board of Therapeutic Guidelines Limited

The constitution of Therapeutic Guidelines Limited (TGL) stipulates that the Board of TGL shall comprise nine directors.

Directors hold office for three-year terms (*commencing on the date from which the person consents to his/her appointment and concluding at the expiration of the third annual general meeting of the company following appointment*).

The terms of two Directors' positions are to be filled at this meeting and nominations for these positions are sought. The directors whose terms are due to expire at this meeting are Ms Lisa Kruesi and Professor Debra Rowett. The retiring directors are entitled to be renominated and elected for a further term.

If you wish to be a candidate for one of these positions, nominations must be in writing on the TGL nomination form (enclosed) and signed by 2 members who are entitled to vote at the annual general meeting.

A list of the competencies that are considered to be important for directors is enclosed.

Completed nomination forms must be accompanied by:

- a consent to act as a director (enclosed),
- a curriculum vitae (not more than two A4 pages in length),
- the names of two referees, and
- a letter from the nominee (not more than 500 words) explaining how s/he meets the identified required skills/competencies and how s/he expects to be able to contribute to the Board.

A person who is an existing director of TGL is only required to provide consent to act as a director.

Nominations for election to the Board must be completed in accordance with TGL's nomination process by 17 April 2019 and delivered to:
